Item: Food Report

- -- Starting March 1, clients can get staples once a month, with the option to pick staples any time during month.
- -- Easter "Drive Through Holiday." Clients will go to Church of Christ nearby to get holiday food separate from regular distribution at IFM to avoid back-ups.
- --Food needed: stuffing, applesauce, pudding, pancake batter, syrup, ramen, and Mac and Cheese

**Action:** Sue authorized to give food to Bear River High school program, which is starting Jr. High program. (note: In future will give Ex. Dir. more leeway on such decisions without board vote.)

Item: Volunteers Needed

IFM will focus on volunteer recruitment in the future. VP of Operations needed. Board asked to look for volunteer for this position.

**Item:** Partnering Against Hunger

Expansion to better serve clients is in progress.

- -- Real estate offer has been agreed to: 45-day contingency time.
- -- Parking area and other needs to be determined
- -- USDA loan requirements complicated. Goal is to pay off in 5 years.
- --Strategic plan for 5 years needed.

**Action :** Motion – Bob and Sue (with Dick S.) authorized to spend up to \$25,000 from the building fund in support of the building project. Passed Motion 2 – Bob and Sue (with Dick S.) to be given signing authority pertaining to moving forward regarding real estate at 440 Henderson St. for next 45 days. Passed.

- --Grants Sue is pursuing grants from United Way and Community Service Block Grants
- --June 22 event at Fairgrounds. Aimed at targeted group of community leaders, not general public. Individuals will be encouraged to purchase table of tickets.
